

## Privacy Notice pursuant to Articles 13-14 of Regulation (EU) 2016/679

### Data Subjects: Carriers.

COMBUSTION CHAMBER COMPONENTS CCC SRL, in its capacity as Controller of the processing of your personal data, pursuant to and for the purposes of Regulation (EU) 2016/679, hereinafter “GDPR,” hereby informs you that the aforementioned legislation provides for the protection of data subjects with regard to the processing of personal data, and that such processing will be based on the principles of fairness, lawfulness, transparency, and the protection of your confidentiality and your rights.

Your personal data will be processed in compliance with the legislative provisions of the aforementioned regulation and with the confidentiality obligations therein provided.

**Purpose and Legal Basis of the Processing:** Specifically, your data will be used for the following purposes connected with the execution of measures related to contractual or pre-contractual obligations:

- transport operations.

**Methods of Processing.** Your personal data may be processed in the following ways:

- outsourcing of processing operations to third parties;
- processing by means of electronic devices;
- manual processing using paper-based archives.

All processing is carried out in compliance with the provisions of Articles 6 and 32 of the GDPR and through the adoption of appropriate security measures as provided therein.

Your data will be processed exclusively by personnel expressly authorized by the Controller and, in particular, by the following categories of authorized personnel:

- Purchasing Department;
- Administration Department.

**Disclosure:** Your data may be disclosed to external parties for the proper management of the relationship and, in particular, to the following categories of recipients, including all Data Processors duly appointed:

- within public and/or private entities for which the communication of data is mandatory or necessary for compliance with legal obligations, or is in any case functional to the administration of the relationship.

**Dissemination:** Your personal data will not be disseminated in any way.

**Retention Period.** We inform you that, in compliance with the principles of lawfulness, purpose limitation, and data minimization, pursuant to Article 5 of the GDPR, the retention period for your personal data is:

- established for a period no longer than necessary to achieve the purposes for which the data were collected and processed, and in compliance with the mandatory time limits prescribed by law.

**Regulation (EU) 2016/679: Articles 15, 16, 17, 18, 19, 20, 21, 22 – Rights of the Data Subject**

1. The data subject shall have the right to obtain confirmation as to whether or not personal data concerning him or her are being processed, even if not yet recorded, communication of such data in an intelligible form, and the right to lodge a complaint with the supervisory authority.
2. The data subject shall have the right to obtain information as to:
  - a. the origin of the personal data;
  - b. the purposes and methods of the processing;
  - c. the logic involved in any automated processing carried out with the aid of electronic means;
  - d. the identity and the contact details of the controller, the processors, and, where applicable, the controller's representative in the Union pursuant to Article 27;
  - e. the recipients or categories of recipients to whom the personal data may be disclosed or who may become aware of them in their capacity as designated representatives in the territory of the State, processors, or persons authorized to process personal data under the authority of the controller or processor.
3. The data subject shall have the right to obtain:
  - a. the updating, rectification, or, where interested, integration of the data;
  - b. the erasure, anonymization, or blocking of data processed unlawfully, including data whose retention is unnecessary for the purposes for which they were collected or subsequently processed;
  - c. certification that the operations referred to under points (a) and (b) have been notified, also as regards their contents, to those to whom the data were communicated or disseminated, except where this proves impossible or involves a disproportionate effort compared to the right being protected;
  - d. data portability.
4. The data subject shall have the right to object, in whole or in part:
  - a. on legitimate grounds, to the processing of personal data concerning him or her, even though they are relevant to the purpose of the collection;
  - b. to the processing of personal data concerning him or her for the purpose of sending advertising materials or direct selling or for carrying out market research or commercial communication.
